Objective

The objective of this exhibition is to give the Associate Members an opportunity to display representative examples of their current "Body of Work". Each artist accepted must display three pieces that were created in the same medium, and are stylistically and thematically consistent with each other. As you select your body of work, imagine you were invited to exhibit in a gallery, you would want to convey that the same artist was responsible for all of the artworks.

Requirements for Submission

1. Applicants must be a current AAG Associate member. If you are not current, you may pay dues when submitting your artwork. If you are not a member, you may fill out an application and pay dues when submitting your artwork.
2. Entries must be the original work of the applicant and created within the last two years.
3. Artwork must not have been accepted into any previous AAG juried exhibitions.
4. Members shall submit a body of 3 works of art.
5. All media are acceptable. Artwork must be created of quality materials. All materials must be completely dried. Clay must be fired. Dried, unfired paper-clay is acceptable.
6. Two- dimensional art must be wired substantially for hanging (NO saw-tooth hangers). The wire should be no more than 1/4 of the way from the top and should have a slight bow. Gallery wrap canvas must be a minimum of 1 1/2" deep, painted on all sides and stapled on the back only. Mats must be neutral in color, clean, and professional in presentation.
7. There is no minimum required dimension for artwork. The maximum width for two-dimensional artwork must not be larger than 40" including the frame. Maximum height is 75". Three-dimensional works must not exceed 50 lbs.
8. Any accepted artwork that is sold during this exhibition is subject to a 15% contribution to AAG.
9. Artwork will not be released before the conclusion of the Exhibition for any reason.
10. One set of tags taped to the backside bottom left of each piece of artwork. Additionally, each piece should be labeled with artists name and title on the back of the piece.

Entry Fees

\$40 for all three

Payment receipt and a completed entry form are required at drop-off November 17th. A \$20 fee will be imposed for any NSF check returned. Entry fees are non-refundable.

\$900 in prize money will be awarded!

\$500 – Best in Show

\$250 – Award of Excellence

\$150 – Award of Merit

Jurying Accepted works will be chosen purely based on quality and the individual artist's mastery of the medium and expression, without preference toward any particular school, style or technique.
