Phoenix Airport Museum is presenting the exhibition

Phoenix Sky Harbor International Airport, Terminal 4, Level 3 display, eight cases

Have your art on display in one of the country's busiest airports!

To the Artist: In honor of Arizona Artists Guild's (AAG) 90-year anniversary, Phoenix Airport Museum (PAM) is presenting an exhibition of artworks from its members. Accepted artworks will be chosen by PAM's curatorial staff.

Eligibility: Artists that are members of AAG may submit a **maximum of four artworks** for consideration. Original, two and three-dimensional artworks in **all media** and **styles** may be entered **except giclées of paintings and canvas-wrapped prints**. Artwork must be able to fit in display cases which are 10 feet high by 15 feet wide and 20 inches deep.

Submission: Submissions must be received by **5pm, Friday, August 11, 2017** and include the following:

- Printed list of artworks with descriptions, materials and dimensions of artwork and frame given as height x width.
- Artist contact information including name, address, phone number and email address.
- Questions may be directed to **airport.museum@phoenix.gov** or **602-273-2006**.
- **Images:** One of each submitted artwork plus one optional detail of each artwork. Images must be digital; burned on a CD in JPEG format, 300 dpi and sized approximately 4 x 6". Include a print out of each image on 8.5" x 11" paper. **Digital images must contain artist's last name and title of artwork in the file name. For example:** Smith, Sunrise Over Phoenix.jpg. CDs and application materials **will not** be returned.

Transportation: Artists are responsible for transportation of work to **PAM**. Artworks may be hand-delivered to the Museum's off-site facility or shipped. If artwork is hand-delivered, artist is responsible for delivery and pick up. If artwork is shipped, cost of shipping is the artist's responsibility and **PAM** will pay for return shipping via FedEx unless otherwise arranged by the artist at time of acceptance. Work being shipped must be packed in a re-usable shipping container. Artists are responsible for checking with their shipper regarding insurance and correct packing procedures. **PAM** will not be responsible for breakage because of incorrect packing or an insufficient container. Artists will be notified when their work arrives and of its condition.

Liability: Insurance will be carried by the City of Phoenix on all works while in possession of **PAM**.

Agreement: Accepted artworks must remain on display for the duration of the exhibition. Submission of an entry constitutes permission to photograph work for publicity and educational purposes. All entries must be of original design and personal execution. **PAM** reserves the right to refuse an entry if upon arrival, the artwork is found to be poorly executed or inappropriate for public display.
