# Requirements for Submission

1. Applicants must be a current member of AAG.
2. Entries must be the original work of the applicant and created within the last two years.
3. Artwork must not have been accepted into any previous AAG juried exhibitions.
4. Members may submit a maximum of 3 works of art.
5. All media are acceptable, however there is limited space for 3-D Art. Artwork must be created of quality materials. All materials must be completely dried. This space is a public space with working offices; art works will hang in hallways, meeting rooms and waiting area.
6. Two- dimensional art must be wired substantially for hanging (NO saw-tooth hangers). The wire should be no more than 1/4 of the way from the top and should have a slight bow. Gallery wrap canvas must be a minimum of 1 1/2" deep, painted on all sides and stapled on the back only. Mats must be neutral in color, clean, and professional in presentation.
7. There is a **12-inch minimum and 40-inch maximum width** for two-dimensional artwork. Three - dimensional artwork must fit on 16-inch pedestals max.
8. Any accepted artwork that is sold during this exhibition is subject to a 15% contribution to AAG.
9. Artwork will not be released before the conclusion of the Exhibition for any reason.
10. AAG is responsible to host the openings and your support is required for hosting duties. Artist support is necessary for these openings. A sign-up sheet will be available at artwork drop off, at least 3 people are required for each hosting event. Be sure to sign-up when you drop off your art. The reception dates are listed in the schedule. First Studio is on the First and Third Friday's tour route and they receive very high traffic for these events.
11. Artwork identification; One set of tags shall be taped to the bottom left (and exposed) of each piece of artwork. Additionally, the Artist is required to also attach their contact information and artwork title to the back or bottom of the piece.

Three Works: \$40
