## Requirements

1. The artist must be over the age of 18, and a current resident of the State of Arizona.
2. Submitted artwork must be original works of art in concept and design, made solely by the artist. Must have been created within the past 2 years.
3. All visual art media accepted.
4. All artwork must be submitted as digital images. Your images should be saved in baseline standard JPEG format. Do not save as a 'progressive' JPEG. Image resolution should be set to 1200 pixels width. Submit only one image per piece of artwork. However, up to 3 views of sculpture works may be submitted. Videos of kinetic sculpture must be submitted in .mov format.

5. Three-dimensional work is not to exceed 50 lbs. Artists requiring pedestals larger than 12"x12", please provide notification.

6. Two-dimensional work to be wall-hung must not exceed 50 inches wide measured at the outside of the frame and must be adequately wired and ready to hang (no saw tooth hangers). The hanging wire must be placed no more than one quarter of the way from the top of the frame. Artwork with frames considered below minimal gallery standards will not be displayed nor considered for award. Mats must be neutral in color, clean and professional in presentation. Gallery wraps are acceptable provided they are at least 1-1/2 inches deep and are painted on all four sides.

7. All artwork must be priced and available for sale (no 'NFS') and the price should include a 25% commission payable to the West Valley Arts HQ.

The artist retains copyright to the artwork; however, Arizona Artists Guild reserves the right to photograph and publish images of the artwork for the purposes of promotion for this exhibition and future exhibitions.

8. Accepted artwork must be clearly labeled with artists name, title of artwork, medium, year of completion, dimensions, and price.

West Valley Arts HQ takes a commission of 25% on all sales, AAG does not take a commission on this show. Please plan accordingly when pricing your artwork.
