How to Apply

Applications are being accepted on-line only at ArizonaArtistsGuild.net via entrythingy.com.

Requirements

1. The artist must be over the age of 18, and a current resident of the State of Arizona.
2. Submitted artwork must be original works of art in concept and design, made solely by the artist. Artwork must have been created within the past 2 years.
3. All visual art media accepted.
4. Two-dimensional work to be wall-hung must not exceed 50 inches wide measured at the outside of the frame, and must be adequately wired and ready to hang (no saw tooth hangers). The hanging wire must be placed no more than one quarter of the way from the top of the frame. Artwork with frames considered below minimal gallery standards will not be displayed nor considered for award. Mats must be neutral in color, clean and professional in presentation. Gallery wraps are acceptable provided they are at least 1-1/2 inches deep and are painted on all four sides.

5. Three-dimensional work is not to exceed 50 lbs. Artists requiring pedestals larger than 12"x12" must supply their own pedestal.

6. Each artist may submit up to three pieces of artwork. However, due to gallery space limitations, the maximum number of works accepted into the exhibition by any one artist will be two.

7. All artwork must be submitted as digital images. Your images should be saved in baseline standard JPEG format. Do not save as a 'progressive' JPEG. Image resolution should be set to 1200 pixels width.

Submit only one image per piece of artwork. However, up to 3 views of sculpture works maybe submitted.

Videos of kinetic sculpture must be submitted in .mov format.

8. All artwork must be priced and available for sale (no 'NSF') and the price should include a 30% commission payable to the City of Glendale.

The artist retains copyright to the artwork, however Arizona Artists Guild reserves the right to photograph and publish images of the artwork for the purposes of promotion for this exhibition and future exhibitions.

9. Accepted artwork must be clearly labeled with artists name, title of artwork, medium, year of completion, dimensions, and price.

10. Participating artists are encouraged to volunteer for gallery sitting during open hours

Optional Delivery of Accepted Artwork

It is expected that all artwork will be hand-delivered to Westgate Gallery by the artists. If this is not possible, the artwork may be shipped by prior arrangement to the Arizona Artists Guild building, 18411 N 7th Ave. Phoenix, AZ 85032 to arrive on Monday, February 29, 2016. If shipping artwork, artist must enclose a check for \$25.00 payable to AAG to cover the expense of uncrating, storage of crate, re-crating and contacting your shipper for return. In a separate envelope include the appropriate return shipping label with your personal FedEx or UPS account information.
